1 Booth Rental Fee

1-1 A 30% discount will be offered to exhibitors who apply 4 or more booths (over 36m²) at one location. (This discount does not apply in the case of 4 booths(36 m²) or less.)

1-2 Booth specifications:

Space only.(If the exhibitor requires partitions, the Organizers will provide standard size partitions free of charge.)

Please refer to the "Exhibitors' Manual" for information about booth packages, including basic decor.

1-3 The booth rental fee includes the following:

- (1) Exhibition space during the Fair as well as the delivery/removal periods.
- (2) Exhibitors' badges valid for the duration of the exhibition.
- (3) Visitor invitations.
- (4) Listing in various printed materials published by the Organizers and on the JIMTOF official website.

1-4 Payment of utilities and service fees (after the Fair):

The Organizers will invoice Exhibitors for use of the following utilities and services after the Fair.

- (1) Electricity, water supply and drainage, compressed air, communication equipment, and flooring works
- (2) Visitor Invitations fees (if the number of invitations exceeds the specified number)
- (3) Organization of Exhibitor workshops
- (4) Advertisements in printed materials published by the Organizers
- (5) Visitor registration system
- (6) Registration of information on co-exhibitors and represented companies
- (7) Other paid services provided by the Organizers

3 Application

3-1 Application period

October 2, 2023, to February 29, 2024

*Please note that applications will only be accepted during the above period.

* Some applications may not be accepted depending on the situations of application.

3-2 How to apply

- (1) Please apply online using the "Exhibitor Application Form" only for this area on the official JIMTOF website.
- (2) If multiple companies apply to use the same booth, one company shall act as the representative and be responsible for the application, payment of fees, and all other required procedures.

For Exhibitors who are not the representative Exhibitor:

- Exhibitors with their own employees, products, and services at the exhibit booth shall be considered "co-exhibitors."
- Exhibitors without their own employees at the booth, but offer their own products and services shall be considered "represented companies."

Co-exhibitors and represented companies may register separately for a fee after the application is approved.

(3) The representative submitting the application must have the appropriate authority within the applicant organization to sign the agreement to exhibit at the Area.

(4) Should any of the information provided in or with the application change at a later date, please notify the JIMTOF Fair Management Office at Tokyo Big Sight Inc. as soon as possible to obtain approval.

3-3 Application timeline (*Subject to change)

March	Invoice of the booth rental fee
End of April	Payment deadline for the invoice * Cancellation fee after the deadline : 100% of the booth rental fee(total amount inclusive of the tax)
May	Notification of booth location
May- June	Exhibitor briefing (Tokyo, Osaka, Nagoya)
June - November	Submission of all application documents for services
November	JIMTOF 2024 Tuesday, November 5 to Sunday, November 10
December	Invoice(s) issued after the end of the Fair for utilities and service fees

3-4 Application approvals, Exhibition agreement and Payment terms

After an application is received, the Organizers will notify the applicant in writing to officially inform them that the application for participation in the Area has been approved by the end of March 2024. The agreement shall be deemed concluded when the Organizers send the official notification to the applicant that the application for participation in the exhibition has been approved.

The Organizers will send Exhibitor the invoice of the booth rental fee after notification of participation in the exhibition officially. Exhibitors shall remit the amount specified to the designated bank account by the due date indicated on the invoice.

(Bank handling charges shall be borne by Exhibitors.)

3-5 Cancellation or modification of exhibition agreement

Exhibitors may not cancel or modify the exhibition agreement, in principle, whether in whole or in part, once the agreement has been signed, except to the extent that the Exhibitor notifies Organizers of such intention in writing or otherwise and obtains its consent thereon, in which event, however, the Exhibitor shall be required to pay a penalty to Organizers in the amount set forth in the table below, according to the date that the Organizers receive notification in writing or otherwise from the Exhibitor.

Deadline	Cancellation fee
On or after the date on which the lump sum payment for the booth rental fee is due	100% of the booth rental fee (total amount inclusive of the tax)

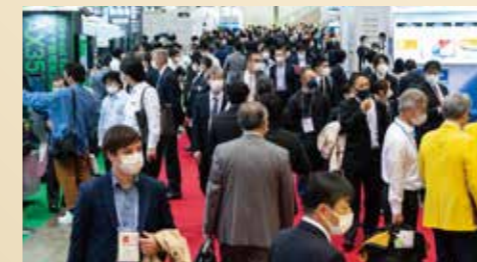

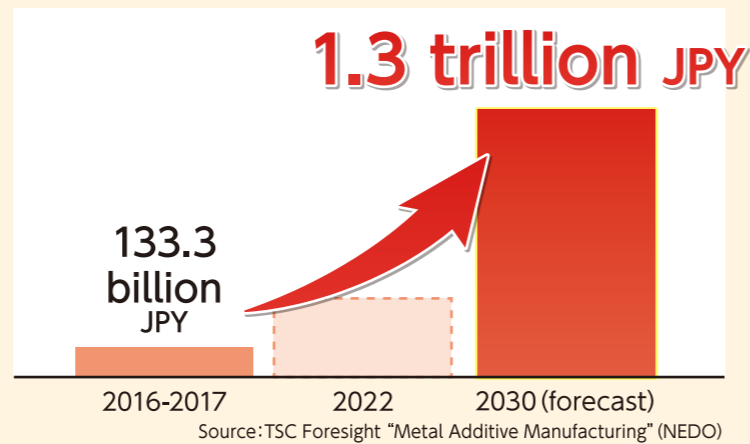
Additive Manufacturing Area in JIMTOF 2024

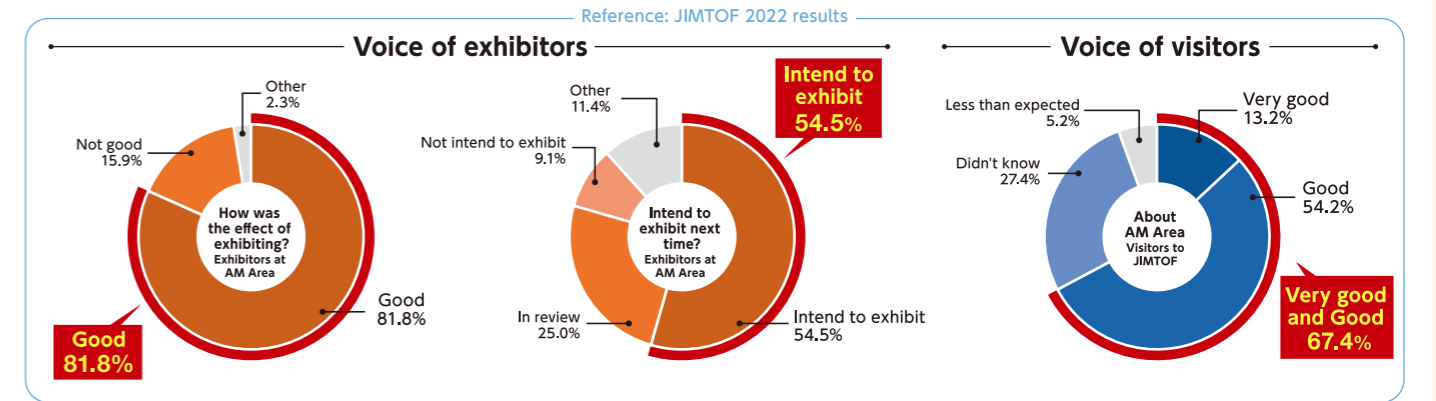


Concurrent Exhibition of JIMTOF specializing in Additive Manufacturing and 3D printing

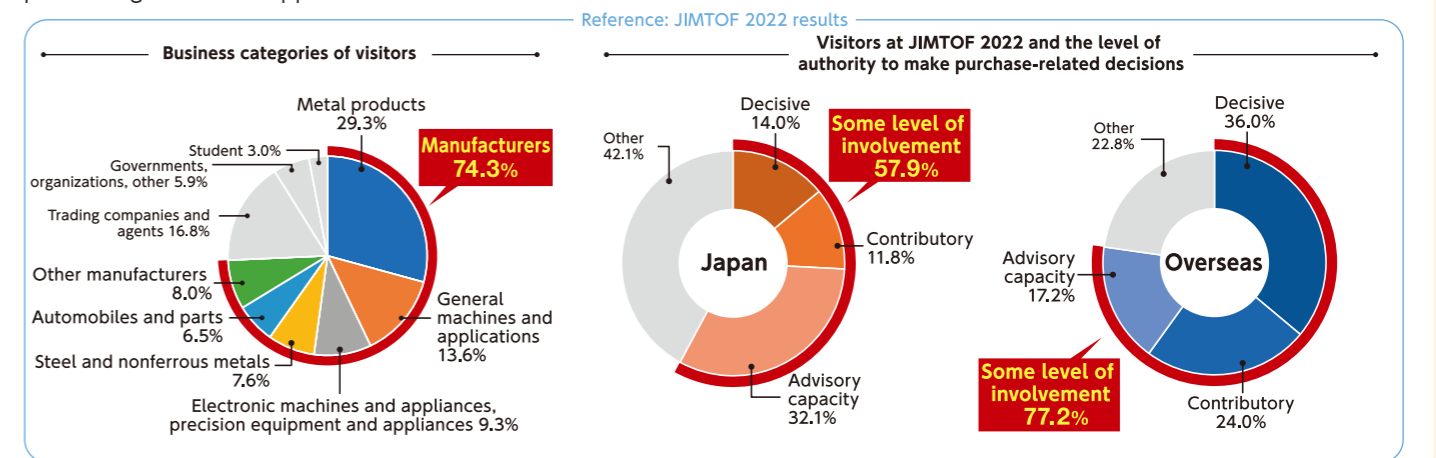


Potential to attract visitors, with a focus on the manufacturing industry, and ample opportunities to talk business face to face
